Political Career:

After 24 year career as a Medical Doctor attached to the Ministry of Health, , where I was able to serve the people of Sri Lanka I resigned from my post to become a full time Politician to serve the Community in a different manner in 2009 after the assasination of my beloved husband, who was a dedicated and renouned politician in Sri Lanka, in the year 2008,

I contested the parlimentary elections and was elected to the 7th Parliament in 2010.

I was an active member of the parliment and held many posts being the chairperson of the Public Petition Committee and subcomittee to investigate issues related to women.

I also served as a member of many parlimentary select committees on Health, Education, Child Development & Women's Affairs, Investment Promotion, Foreign affairs, etc. I was also a member of the parlimentary select committee to propose recommendations for the constitutional amendments committee to study and propose recommendations on Chronic Kidney disease in Sri Lanka,

I was re-elected to the 8th Parliment after the General elections which were held in August 2015 and was initially appointed as the Deputy Minister of Higher Education

during the 1st National government formed in January 2015 and then as the State Minister of **City** Planning and Water Supply in September in 2015. I was the chairperson of the Sri Lanka Freedom Party (SLFP) women's wing a post which I have been holding since **2014**.
